The Government have sanctioned Adhoc Bonus/Special Festival Allowance to the State Govt. Employees vide G.O read as 2<sup>nd</sup> paper above. Accordingly a note was submitted to the Honourable chairman in this regard for sanctioning Adhoc Bonus/Special Festival allowance to the employees of CAPE and got approved for disbursing the same as shown below subject read as 3<sup>rd</sup> paper above.

In the circumstances it has been decided to sanction Ad-hoc Bonus/Special Festival Allowance to the employees of CAPE as on 31.03.2019 for the year 2019 as shown below.

Also resolved to sanction an amount Rs15,000/- as Onam Advance to all regular employees. The Regularized and Part-Time contingent employees are also permitted to draw an amount of Rs.7,500/- & Rs.5,000/- respectively as Onam advance. The advance so availed by the employees shall be recovered in five equal monthly instalments from their pay & allowances for the month of October 2019 onwards.

In the circumstances, the following orders are issued for early compliance.

## ORDER

- i. Sanction is accorded to all the Head of the Institutions to draw and disburse Adhoc Bonus/Special Festival Allowance to the eligible employees as mentioned above table subject read as 3rd paper above.
- ii. Sanction is also accorded to draw and disburse Onam advance of Rs.15,000/-(Rupees fifteen thousand only) to all regular employees and who are willing to accept Onam Advance. The Regularized and Part-Time contingent employees are also permitted to draw an amount of Rs.7,500/- & Rs.5,000/- respectively as advance.
- iii. No advance shall be granted after Onam. The advance so availed by the employees shall be recovered in five equal monthly installments from their pay & allowances for the month of October 2019 onwards. A separate register shall be maintained for recording the recovery of Onam Advance.
- iv. Those who were on leave without allowance as on 31.03.2019 for Joining Spouse Aboard or employment propose in India or abroad will not be entitled for Adhoc Bonus.
- v. Service Pensioners who are employed/re-employed in CAPE Service and eligible for Ad-hoc Bonus/ Special Festival Allowances from Govt. exchequer vide G.O. (P)No. 116/2019/Fin dated 26.08.2019 are not eligible for receiving Ad-hoc Bonus/ Festival Allowance etc from CAPE fund.
- vi. Eligibility of Ad-hoc Bonus/ Festival Allowance/Onam Advance other than the above conditions will be accepted from G.O. (P) No. 115/2019/Fin dated 26.08.2019 G.O. (P)No. 116/2019/Fin dated 26.08.2019.

All Head of Institution shall draw and disburse the Ad-hoc Bonus /Special Festival Allowance, and Advance to all employees of CAPE from 4th September 2019 onwards, in view of ensuing Onam Festival.
