Item No.3: Increasing the number of faculty as per AICTE norms & appointing of Physical Education Lecturer.

To applying for new courses number of faulty in the college should be increased. Thus, TEQIP targets (such as accreditation, starting of new PG courses etc.) can be met as well as the release of next block of grant from NPIU.

So, BoG decided necessary steps should be taken to convince the CAPE, to fill the 75% of faculty with regular hands and the remaining vacancy with adhoc. Principal will present the matter to the director and convincing to take take urgent steps to appoint the required staff members.

Item No.6: Remedial Classes – Remuneration to faculty and other staff – Refreshment charges of students.

BoG decide to adopt the remunerative pattern suggested by the minutes of Principals meeting held on 02-03-2012, for remunerative teaching in EAP. The following remuneration pattern is approved with retrospective effect.

Honorarium to faculty / expert @ Rs. 600/- per hour and for (Lab/Workshop) staff Rs.250/- per hour.

The BoG also decided to spend a maximum amount of Rs. 50/- per student for lunch and light refreshments, those who are attending the remedial classes under EAP, with reference to minutes of the Principals of Engg. Colleges selected under Sub-Component 1.1 of TEQIP Phase II, convened by DTE on 02-03-2012 at DTE, Thiruvananthapuram.
