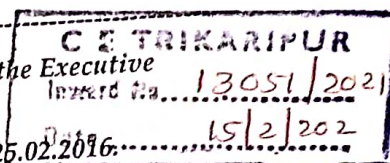

CAPE-Estt-Granting Scales of Pay and eligible compensatory allowances to Regularized employees - Sanctioned - Orders Issued:

As per this office proceedings read as 2nd paper above orders were issued to regularize provisionally 59 non-vacation employees working on contract basis in CAPE Head Office, Engineering Colleges, IMT and KIMB who have been serving CAPE continuously for more than three years as on 05.02.2016 without considering one day break/short break in between the extensions on the condition that formal regularization orders would be issued only after verification of their eligibility to be regularized against the respective posts held by them as decided by the 154th Executive Committee Meeting.

Accordingly orders were issued to regularise 45 employees who possess required qualifications and service subject to the condition that during the probation period they will be eligible only for the basic pay at the minimum of the corresponding scale of pay of the post to which he/she is appointed or the present pay drawn by him/her whichever is higher. Out of which four employees were resigned from the post in which they regularized.

The 161st meeting of the Executive Committee held on 13/12/2017 resolved to approve 50% hike in the basic pay drawn by the regularized employees w.e.f 01/12/2017.

As per the decision of 174th meeting of the Executive Committee, a detailed proposal was submitted to the Government for sanctioning the scale of Pay and Other allowances to the regularised employees vide paper read as 4th above. Government have permitted to grant corresponding scale of pay to the regularized employees as recommended by the 174th meeting of the Executive Committee vide paper 5th cited.

ORDER

In the circumstances sanction is accorded to grant Scale of Pay to the regularized employees as shown below. They will also be eligible for compensatory allowances attached to the post including Dearness Allowances.
